Transparent and Green

Introduction

- 1. The Inter-Parliamentary Union (IPU) promotes democracy, global governance and peace-building through a broad range of activities carried out by, and with the support of its Members the parliaments. The annual budget allows the organization to pursue these overall objectives.
- 2. The consolidated budget gives a multi-year perspective for the future development of the Union with increasing support from voluntary contributions.
- 3. For 2008, the consolidated budget has gross operating expenditures of CHF 20,131,400 as compared to CHF 17,456,720 in 2007. A target for voluntary funding has been set at CHF 7,450,000. Members' assessed contributions will increase by four per cent to CHF 11,354,900. The balance of revenue will come from staff assessment and other sources.
- 4. The budget focuses on results and offers indicators of achievement. It shows Members as clearly as possible what they can expect from the expenditures that they fund. The document also presents the relative positions of men and women in the internal structures of the IPU and the resources given to gender issues and activities. Gender specific appropriations from regular funds have increased by 11 per cent, or CHF 74,400, over 2007 to CHF 727,400 representing 6 per cent of all regular funding.
- 5. In this budget, the Inter-Parliamentary Union is making a commitment to the environment and to curbing climate change. It is acknowledging its greenhouse gas emissions, setting targets for reductions, and proposing appropriate mitigating measures, including the purchase of carbon offset credits.

Carbon offsets

The idea of offsetting greenhouse gas emissions by paying for projects that reduce the gases elsewhere was adopted at the Kyoto Summit in 1997. There is now a large voluntary market in which companies and individuals buy carbon credits from sellers who invest in energy conservation projects.

Events such as the G8 Summit, the annual meeting of the Inter-American Development Bank, and the UN Conference on Climate Change have been declared carbon neutral through the purchase of offsetting credits.

The sale of carbon credits is unregulated and the market offerings, while well meaning, are unreliable. Effective offsetting requires: (a) accurate computation of emissions; (b) accurate estimation of carbon saved elsewhere; and (c) guarantees of additionality – that the energy savings would not have happened regardless.

The IPU budget proposes a direct investment in energy conservation and advocacy as an alternative to purchasing third party offerings.

IPU carbon footprint

- 6. Delegates at the 114th Assembly passed a resolution calling on parliaments to take action on global warming, bearing in mind that a drastic decrease in greenhouse gas (GHG) emissions is required. In May 2007, this resolution was reinforced by a Presidential Declaration calling for increased community understanding of the threat of climate change and pledging to raise the issue of climate change in parliaments.
- 7. To effect change requires knowledge and understanding. As part of IPU's commitment to tackle climate change, the Organization has established 2000 as its base year and is counting its GHG emissions in order to track progress and identify priority areas for action.
- 8. The IPU carbon footprint has been determined in accordance with the framework set out by the World Business Council for Sustainable Development under the GHG protocol. The IPU emissions inventory includes scope 1 direct emissions from heating and vehicle use and scope 3 indirect emissions associated with air travel, employee commuting, and paper use. Scope 3 indirect emissions by participants in IPU activities are quantified separately.
- 9. The direct emissions of the IPU were 43 tonnes of CO2e¹ in the base year 2000. From 2000 to 2005, IPU direct emissions increased by 75 per cent to 75 tonnes. Over the same period, the indirect emissions of the IPU resulting from official travel by staff, paper consumption and commuting decreased by 20 per cent to from 1231 tonnes to 985 tonnes of CO2e. In addition, it is estimated that delegates to major IPU meetings generated 18,000 tonnes of emissions by air travel in 2005, the same as in 2000.

Mitigating the Damage

- 10. Conservation is not a new idea. The IPU Headquarters in Switzerland has energy conserving lighting and blinds. Since 2006, IPU reports are printed on 100 per cent recycled paper and waste paper is recycled. However, the goal is to become more systematic and more innovative in conservation efforts. Where the IPU cannot conserve, it can pay others to conserve.
- 11. In 2008, subject to the approval of funding, the IPU will set aside funds to offset CO_2 emissions and mitigate the environmental impact of operations. A provision of CHF 46,200 will offset 1144 tonnes of emissions from regular activities. Voluntary funds will be used to offset the emissions from project activities.
- 12. Over the medium-term the IPU will seek to reduce direct and indirect CO_2 emissions to 90 per cent of 2000 base year levels. The target is consistent with the pledge made by Switzerland, the host country, under the Kyoto Protocol.

¹ CO2e means carbon dioxide equivalent which is a universally accepted measure encapsulating all greenhouse gases.

13. Most of the operating revenue of the IPU comes from Members' assessed contributions. Since 2003, the Union has honoured its commitment to hold overall fee increases to just 3.0 % per year to meet the cost of inflation. However, the budget for 2008 requires a modest real increase in funding. IPU is calling for a 4 per cent increase in assessed contributions to CHF 11,354,900. The increase can be attributed to Promotion of Democracy (1.0 %), External Relaions (1.0 %), Support Services (1.0 %), the Executive Office (0.5 %) and purchasing carbon offset credits (0.5 %).

14. In 2006, the Governing Council

adopted a new scale of assessment which is directly related to the United Nations scale of contributions. The new scale reflects current economic realities and reduces the burden of contributions on the least developed countries. Next year will be the second year of transition to the new scale of assessment, and as a result 82 parliaments will see reductions in their contributions compared to 2007.

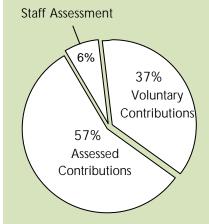
Staff Assessment

15. As international civil servants, and in accordance with the Staff Regulations approved by the Executive Committee in 1975 and the UN common system of salaries, allowances and benefits approved by the Executive Committee in 2005, IPU staff members pay an internal staff assessment to the IPU. The rate of assessment is established by the International Civil Service Commission. This system of internal taxation will generate gross revenues of CHF 1,315,900 in 2008 for the benefit of all Member Parliaments. However, the estimate of revenue from staff assessment has been reduced by an estimate of the national income taxes to be reimbursed to staff. To avoid double taxation, the Union is obligated to refund to staff members the lesser of the staff assessment or the amount of any national taxes that they pay. Refunds to staff members living in France are projected to amount to CHF 60,000 in 2008.

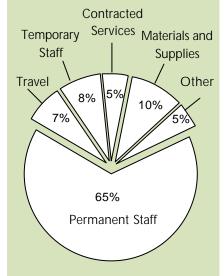
Other Revenues

16. Incidental revenues from administration fees, room rentals, book sales, etc. are expected to amount to CHF 70,600 in 2008. Interest revenues of CHF 75,000, which have not been included in the operating estimates, will be contributed directly to the Working Capital Fund in accordance with the financial regulations.

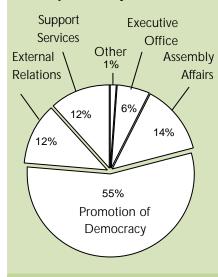
Revenues by source

Voluntary Contributions

- 17. Members' assessed contributions are not sufficient to support the realization of the IPU's potential. The expanded agenda, which includes projects to promote democracy, global governance and peace-building, requires more funding that is both predictable and flexible. The IPU has taken steps to replace an ad hoc approach to fundraising with a systematic effort to build a stable funding base for its programmes. This was manifest in a four-year plan that was presented to the Governing Council in 2006 and subsequently used as a resource mobilization tool.
- 18. The fundraising goal for 2008 has been set at CHF 7.5 million compared to a goal of CHF 5.1 million in 2007.
- 19. By 31 August 2007, the IPU had hard or soft funding commitments for 2008 totaling CHF 1.4 million from UNDEF, European Commission, UNDP, Qatar, and the International Organization of the Francophonie. Proposals were under active consideration by SIDA (Sweden), CIDA (Canada), and Irish Aid. Discussions were continuing with the foreign ministries of Belgium, Finland, Norway and Sweden.

Medium-Term Expenditure Outlook

- 20. Last year, the Secretary General announced an ambitious plan to equip the IPU to meet today's challenges as a global parliamentary organization. The plan called for more work in three key policy areas: democracy, global governance and peace-building, for which it would be necessary to mobilize substantial additional financial resources from voluntary sources.
- 21. Raising substantial amounts of funds from new donors is a gradual and time-consuming process. Extensive consultations with donors over the past year leading to the submission of specific and detailed funding requests should yield results in 2008. Voluntary funding is projected to increase significantly next year and to continue to increase modestly thereafter.
- 22. Meanwhile, inflation is about 1 per cent in Japan, 2 per cent in the Euro zone, 3 per cent in the USA, and generally higher in emerging markets. Accordingly, the materials and services purchased by the IPU around the world will inflate 2 or 3 per cent on average. The cost of IPU Assemblies, which are a major recurring expense, depends upon the choice of venue, with venues closer to headquarters being generally less expensive for the IPU and generating fewer CO₂ emissions. However, because of visa issues, Assemblies will be held either in Geneva or outside Europe for the foreseeable future.
- 23. Salary costs normally increase at a higher rate than inflation because of annual increments. However, due to several retirements over the period 2009-2011, there will be some relaxation in the pace of total salary costs. Staff renewal will give an opportunity to address issues of grade and gender parity while adding a regular staff post.
- 24. By statute, by decision of the Governing Council, or by generally accepted accounting practice, the IPU is required to make various provisions and reserve contributions each year. These provisions for depreciation, doubtful accounts, replacement reserves, working capital replenishment, and other long-term liabilities are not expected to change materially in the medium term.
- 25. The medium-term expenditure forecast is presented in Table 4 of the Supporting Documents. The projection shows that with all of the above factors considered, assessed contributions will continue to rise at a rate of approximately 3 per cent each year denominated in Swiss Francs. Medium-term expenditure projections will be reviewed annually, particularly in light of the success of resource mobilization.

Expenditure Estimates

26. Expenditures are controlled in six cost centres corresponding to the Executive Office of the organization, the four substantive divisions -- (i) Assembly Affairs and Relations with Member Parliaments, (ii) Promotion of Democracy, (iii) External Relations, and (iv) Support Services -- and a cost centre for grants and reserve contributions.

Executive Office

CHF 1,190,500 + 4 per cent increase 3 staff positions 147 tonnes CO2e

- 27. The Executive Office, including both the President and the Secretary General, provides leadership and direction to the Union and its Secretariat.
- 28. Support to the President consists of an honorarium and reimbursement of travel expenses related to annual Assemblies and other official meetings of the Union. The honorarium of CHF 30,000 unchanged since 1999 is not in any way related to the financial implications of the role and function of the Office and the President is expected to receive substantial additional support from his or her parliament. CHF 30,000 has been budgeted for the travel expenses of the President and his aide.
- 29. Given the increasing demand for representation of the IPU around the world, the provision for travel by the Secretary General and aides has been increased by 24 per cent to CHF 168,000-sufficient for 20 international trips in business class and 160 days of accommodation. Increased travel will result in increased CO_2 emissions.

Assembly Affairs and Relations with Member Parliaments

CHF 2,782,900 - 5 per cent decrease 7.5 staff positions 503 tonnes CO2e

- 30. The Division for Assembly Affairs and Relations with Member Parliaments facilitates the work of Members when they consider questions of international interest and concern and fosters contacts, coordination and exchange of experience among them. The Division will organize three meetings in 2008.
- 31. The 118th Assembly in May 2008 will be held in Cape Town hosted by the South African Parliament. Because Cape Town is less than 16 hours' flight time from Geneva and in the adjacent time zone, the transportation and rest costs will be reduced compared to 2007. However there will be cost increases due to a revised scale of fees for freelance translators the first revision since 1989 -- and the provision of funds for guest speakers. The overall cost of the meeting, which will be CHF 808,000, is higher than the 114th Assembly in Nairobi but less than the 116th Assembly in Nusa Dua.
- 32. The 119th Assembly in Geneva in October 2008 will follow the format adopted in 2007, consisting of a general debate and a meeting of the Committee on UN Affairs. As there will be only two parallel events rather than three, the requirements for meeting rooms, interpreters, etc., will be reduced. However, the price of services at the Geneva conference centre has increased and funds are also needed for hosting a reception. The cost of the meeting will be CHF 394,600, which is a saving of about CHF 100,000 compared to previous years.
- 33. Funds of CHF 5,000 are provided for an information seminar for IPU Members at the Geneva headquarters in November that will be conducted in French in 2008.
- 34. The Division regularly communicates with Members, documents their functioning and activities, and provides the official translations of IPU documents. The IPU also supports the unofficial translation service provided by the secretariat of GRULAC.
- 35. In moving towards sustainability, the IPU will invite future host parliaments to consider organizing carbon-neutral events and will recommend that delegates offset their travel emissions.

Promotion of Democracy

REGULAR FUNDING:

CHF 3,713,800 + 3 per cent increase 14 staff positions 277 tonnes CO2e

- 36. The Division for the Promotion of Democracy provides advisory services and technical assistance to parliaments, undertakes research, promotes human rights work in parliament and defends the human rights of their members, promotes equal participation of women and men in political activity, enhances child protection, promotes respect for international humanitarian law and mobilizes resources for all these actions.
- 37. **Technical Cooperation and Resource Mobilization:** The technical cooperation programme aims to strengthen the capacity of parliaments, particularly in fragile States emerging from conflict, by developing parliamentary support projects and organizing seminars. As in the past, the Division will organize regional seminars on reconciliation and oversight of the security sector. Additional resources of CHF 81,000 are provided in 2008 to support resource mobilization, to develop parliamentary support for the Brussels Programme of Action, for a workshop on transparency at the 118th Assembly and to respond, as an organization, to urgent political issues by, for example, supporting political dialogue or strengthening parliaments' involvement in peace-building efforts.
- 38. **Resource Centre:** The Resource Centre will continue to collect parliamentary data on a global scale and make it available online through the PARLINE database and in hard copy publications. Research will move away from large-scale comparative analyses to more detailed specific case studies that contain actionable information, including a gender perspective. The theme of transparency that will be developed in 2008 includes the Global Report on ICT in Parliament, which should have a large section on the use of parliamentary websites to make information available to the public. An addition of CHF 30,000 is provided to begin a survey on the representation of minorities and indigenous peoples. The Resource Centre will encourage the publication of information in electronic format and limit the quantity of printed material.
- 39. **Human Rights:** The Union will continue to defend the human rights of parliamentarians through support for the IPU Committee on the Human Rights of Parliamentarians, investigative missions and trial observations. As already approved, the Union will continue to cover the costs of the IPU nominee to the International Independent Group of Eminent Persons observing the proceedings of the Presidential Commission of Inquiry to investigate human rights abuses in Sri Lanka. Expenditures of regular funds for human rights activities will be lower than in 2007.
- 40. **Gender Partnership:** The programme of gender partnership that works for the enhancement of women's political participation will expand in 2008. New activities at a cost of CHF 49,200 will include a revised edition of the map on *Women in Politics* and a grant to the iKnow Politics network. As in prior years, regular funding will enable dialogue between men and women at Assemblies, including a meeting of women Speakers, collection and distribution of data on women in parliaments, and events at the UN Commission on the Status of Women.
- 41. **Child protection and Volunteerism:** In 2008, the IPU will offer a regional seminar on child protection and start a survey on volunteerism. The appropriation will be less than in 2007 by an amount of CHF 10,000. More work in this sphere will be done with voluntary funding.

VOLUNTARY FUNDING:

CHF 7,450,000 45 per cent increase 3 staff positions 2028 tonnes CO2e

- 42. **Projects for Peace, Democracy and Global Governance:** Projects included in the 2008 budget are either already underway or in the pipeline with applications submitted to potential donors or with detailed proposals ready for submission. All of the projects are described in detail in the four year plan of the IPU. Projects for which funding is secure include assistance to women parliamentarians in Burundi, promotion of human rights treaty bodies in francophone Africa, capacity building for the parliaments of Equatorial Guinea and the Democratic Republic of the Congo, and mobilizing parliamentary commitment and expertise on democracy.
- 43. With respect to donor-funded activities, no spending commitments will be made until funding is confirmed, and the duration of any staffing commitments will be synchronized with the funding commitment.

External Relations

CHF 2,356,500 + 4 per cent increase 7.5 staff positions 97 tonnes CO2e

- 44. The Division for External Relations encompasses relations with international organizations, in particular the United Nations and Bretton Woods institutions, and with the US Congress. It also covers all activities which aim at raising public awareness of the IPU, including relations with the media, public education, production and distribution of publications, and constant development of the IPU website.
- 45. The 2008 budget establishes one part-time staff position in the New York Office in place of a consultant, but other costs at the New York Office have been held constant. With respect to events, four parliamentary meetings at the United Nations are planned, the same as in 2007, but additional funds are provided for a meeting of the advisory group of the IPU Committee on UN Affairs. All told, the cost of the New York operations will increase by 4 per cent to CHF 1,116,000.
- 46. Whereas neither the time nor the place of the next ministerial conference of the World Trade Organization is known, the appropriation for a Parliamentary Conference on the WTO has been increased by CHF 12,000 to CHF 143,000 to allow for a meeting away from Geneva. The cost of the Parliamentary Conference, including the cost of preparing a study paper, will be shared with the European Parliament and the sessions of the Steering Committee will be held in Geneva and coincide with other events in order to minimize costs.
- 47. The Division will publish five issues of the *e-Bulletin*, the *World of Parliaments* quarterly and a new information brochure. Resources are also provided for the production of photo and video material and for a follow-up meeting on parliamentary broadcasting. However, funding for technical maintenance of the website and databases is unchanged. The total resource commitment for public information is CHF 1,097,500 an increase of 4 per cent.

Support Services

CHF 2,366,600 + 3 per cent increase 8 staff positions 120 tonnes CO2e

- 49. The Support Services Division administers the material, financial and human resources of the Union and gives administrative policy guidance to the Secretariat. Its goal is to provide optimal service while minimizing costs.
- 49. The operating cost of the Division will increase by CHF 77,600 in order to allow for the orderly succession of departing staff members and for the creation of an oversight and evaluation function, as recommended by the internal auditors and by an organizational review conducted for the Swedish International Development Coopera tion Agency. There will be savings related to the cost of copying equipment and the Internet service, but increases in the cost of building maintenance and depreciation charges.
- 50. The Division will continue to seek environmentally sustainable sources for materials and supplies.

Grants and Reserve Contributions

CHF 271,100 + 257 per cent increase 0 staff positions -1144 tonnes CO2e

- 51. The Union makes provisions for liabilities in keeping with prudent financial management practice. Firstly, there is a provision of CHF 114,900, being 1.0 per cent of assessed contributions, as an allowance for doubtful accounts. The entire amount of the assessed contributions will be recognized as revenue in 2008, but the allowance for doubtful accounts is a provision in the event that Members are later suspended and their contributions are never collected. Secondly, there is a contribution of CHF 55,000 to a reserve for major building repairs, as was decided by the Governing Council in September 2001.
- 52. There are also provisions for two grants. There is a grant of CHF 55,000 to the Association of Secretaries General of Parliaments, unchanged from 2007, and there is a new appropriation of CHF 46,200 for the purchase of carbon offset credits to neutralize the emissions generated by regular operations, including staff travel.

The Secretariat

53. The 2008 budget includes a staff establishment of 43 person-years – no change from the previous year's budget. The table shows the distribution of posts by Division, Programme, Category and Grade and the proportion of posts currently filled by women.

- 54. Grades are established in accordance with the United Nations common system of job classification. As a result of the reorganization in 2005, a few positions are occupied by incumbents at a higher grade than their position is classified. This situation will change through attrition and career development. Most of the staff of the Secretariat are women and significant progress has been made in the past five years in promoting and hiring women into professional positions. A majority of the professional positions are now held by women, including many of the senior professional positions.
- 55. Annual adjustments to salaries are determined by the International Civil Service Commission. The budget for staff salaries in 2008 from regular sources is CHF 6,348,200, an increase of 2.5 per cent from the prior year due to in-grade annual increments and cost-of-living adjustments. A further appropriation of CHF 369,700 is foreseen for salaries for project personnel paid from other sources.
- 56. Benefits such as pensions, dependency allowances and child education allowances are provided to staff in accordance with the UN common system, subject to budgetary approval by the Executive Committee. Some other benefits, such as health and accident insurance, are defined internally by the Union. The budget for staff benefits and overheads from regular sources is increasing by 3.1 per cent over 2007 to CHF 1,955,500 driven by health insurance and pension costs. In addition, the staff benefits charged to project budgets will be CHF 113,900.

Capital Expenditures

57. Capital expenditures are proposed for the essential replacement of deteriorated or obsolete furniture and equipment. A sum of CHF 35,000 will be invested in the purchase of computers to replace outdated workstations and software upgrades. This investment will be amortized over four years on a straight-line basis commencing in 2008. CHF 15,000 will be available for acquisitions of furniture to be amortized over ten years. A capital appropriation of CHF 50,000 will be used for the purchase of a minivan to be amortized over five years. The Union will investigate the viability of purchasing a vehicle powered by electricity, bio fuel or a hybrid in order to minimize its environmental impact.
